# REGISTRATION AND PARTICIPATION CONDITIONS FOR THE GRAND PRIX DE SERRE CHEVALIER

The following registration and participation conditions (hereinafter referred to as the "Conditions") govern the relationship between SCV Domaine Skiable (hereinafter "SCV"), operator of the Serre Chevalier ski resort's ski lifts, and any consumer registering for the sporting competition known as the "Grand Prix de Serre Chevalier" (hereinafter the "Grand Prix") competitor (hereinafter the "Competitor").

**Two routes are offered**: the "Daredevil Route" and the "Gentle Route." For both routes, the start is at the top of the Serre Chevalier cable car (Chantemerle), and the finish is at Salle-Les-Alpes (Pontillas Cable Car Square). The routes are revealed seven days before the Grand Prix.

The routes consist of several timed trials (or "specials") that the Competitor must complete in a predetermined order. Linking stages, connecting one trial's start to another, are not timed.

The Competitor may participate alone or as part of a team with another competitor.

Points are awarded to the Competitor based on the time taken to complete each trial. A ranking is then established among competitors, and a prize ceremony is held at the end of the Grand Prix.

A refreshment area is set up along the route. Additionally, a breakfast is offered at the start of the Grand Prix, at the top of the Serre Chevalier cable car. A meal is also offered to competitors at the finish area in Salle-Les-Alpes. By registering for the Grand Prix, the Competitor unreservedly accepts the Conditions.

#### Information about SCV

SCV is a simplified joint-stock company under French law, with a share capital of €15,012,460.40, registered with the Gap Trade and Companies Register under number 348 799 529, and with an intra-community VAT number: FR 41 348 799 529.

# **Conditions for Participation in the Grand Prix**

# Age Requirements

The Competitor guarantees they will be at least 14 years old on the date of the Grand Prix if registering for the "Daredevil Route," and at least 6 years old on the date of the Grand Prix if registering for the "Gentle Route."

If the Competitor is a minor on the date of the Grand Prix, at least one legal guardian must provide SCV with a signed authorization for participation no later than when the bib is issued to the Competitor. Without this, participation will be refused. A blank authorization form is available on the website: <a href="https://grandprix-serrechevalier.com">https://grandprix-serrechevalier.com</a> (hereinafter the "Website").

# **Physical Condition**

The Competitor guarantees they are in physical condition to exert themselves over approximately 42 kilometers if registered for the "Daredevil Route" or about 30 kilometers if registered for the "Gentle Route."

SCV advises against participation for individuals with certain conditions, such as epilepsy, asthma, or cardiovascular disease.

# Skill Level

The Competitor guarantees they have at least a Class 4 ski level or higher and are skilled in both on-piste and off-piste skiing if participating in the "Daredevil Route." A minimum of Class 2 skiing level or higher is required for the "Gentle Route."

# **Permitted Sports**

If registering for the "Daredevil Route," the Competitor agrees to practice only one of the following sports: skiing, snowboarding, telemark, or monoski.

For the "Gentle Route," permitted sports include skiing, snowboarding, telemark, monoski, snowscoot, tandem skiing, handiski, and handisnowboard.

# Equipment

The Competitor must wear a helmet throughout the Grand Prix. Those participating in the "Daredevil Route" must also carry an avalanche transceiver (DVA), a shovel, and a probe. Without this equipment, participation will be denied.

It is recommended that Competitors wear a back protector, sun-protective goggles or mask, and gloves. No equipment is provided by SCV, except for a bib.

# **Lift Ticket**

The Competitor must hold a valid lift ticket to access the ski lifts operated by SCV on the day of the Grand Prix.

#### **Regisration Process**

# **Registration Procedure**

Registration for the Grand Prix as a Competitor must be completed on the Website. Registration steps include:

- 1. Contact information
- 2. Participant details and route selection
- 3. Team formation (if applicable)
- 4. Payment

During registration, the Competitor may opt for insurance, with coverage details available on the following website: <a href="https://serre-chevalier.monassuranceski.com">https://serre-chevalier.monassuranceski.com</a>.

Registration is complete once SCV has received full payment from the Competitor and, if applicable, the authorization mentioned in section 2.1. An email confirming registration will be sent to the Competitor at the provided email address.

Registration must be completed by the deadline specified on the Website by 11:59 PM.

With a total limit of 2,026 Competitors, registrations may close earlier than the date and time indicated on the Website.

#### **Participation**

# **Bib Wearing and Non-Transferability**

The Competitor must wear the bib assigned to them visibly throughout the Grand Prix.

This bib is non-transferable, whether for free or for a fee. If the Competitor is found to have given their bib to a third party, SCV reserves the right to immediately exclude both the Competitor and the third party from the Grand Prix, with no right to any refund or compensation of any kind.

#### Start

The Competitor must be present at the start of the Grand Prix at the specified time and location as indicated in the registration confirmation email, equipped with the necessary gear and their bib.

# **Compliance with Rules**

The Competitor must comply with posted safety rules on the Grand Prix course and follow instructions given by any member of the Grand Prix organization. Additionally, they are advised to respect the "Ten Rules for Conduct on Slopes" published by the International Ski Federation.

The Competitor must refrain from any behavior that could harm or risk the safety, health, and peace of other competitors or event organizers (e.g., intoxication, verbal or physical violence, use of alcohol or drugs, carrying weapons, using excessively noisy devices, jostling, cutting in line for ski lifts, wearing symbols promoting political or religious opinions that could harm SCV's or the Grand Prix's image, etc.). The Competitor must also avoid damaging any equipment installed for the Grand Prix.

When using SCV-operated lifts, the Competitor must adhere to SCV's terms of use, which are available on the SCV website (<a href="https://www.serrechevalier-pass.com">https://www.serrechevalier-pass.com</a>) and at SCV sales points.

The Competitor must refrain from discarding any waste along the Grand Prix course.

Failure to comply may result in SCV imposing penalties, excluding the Competitor from the Grand Prix without any refund or compensation of any kind, notifying law enforcement, and taking legal action. In the case of non-compliance with lift terms of use, SCV also reserves the right to enforce the relevant provisions in those terms.

# No Priority on Ski Lifts

The Competitor does not have priority access to SCV-operated ski lifts and is prohibited from using lines reserved for ski schools.

# **Timing**

To record participation in a timed trial, the Competitor must cross both the start line, marked by two yellow flags, and the finish line, marked by two pink flags. Failure to do so results in no points being awarded for that trial.

# **Passing**

In timed sections, the Competitor must not obstruct the path of another competitor coming from behind.

#### Withdrawal from the Grand Prix

If the Competitor withdraws from the Grand Prix for any reason at any time, no refund or compensation will be granted.

# Safety Arrangements and Ski Patrol Authorization

Safety and first aid on the ski slopes are provided by qualified personnel equipped with the necessary materials for their duties.

This includes a rescue and first aid service for injured or distressed persons, with first aid equipment, transportation and evacuation tools, and communication devices enabling connection with public emergency services.

Emergency services on the skiable territory of the municipality are carried out in accordance with the local emergency and alert plan.

The emergency number is +33 (0)4 92 25 55 65.

The cost of on-slope rescues will be billed to the rescued individual or their beneficiaries. Rescue costs are approved annually and are subject to a specific municipal council decision.

The individuals responsible for safety and rescue on the ski areas, as well as their deputies, are approved by a municipal order.

The Ski Patrol Director may convene the municipal ski area safety committee at any time according to the order establishing this committee.

In the case of a serious accident, a multi-casualty accident, or delays in state intervention, the Ski Patrol Director is authorized to mobilize a private helicopter and will report this to the mayor.

Rescue costs are invoiced on behalf of the municipality by the Revenue Authority to the beneficiary of an evacuation by the ski area safety service, regardless of the method used or the sport practiced in the ski area (on or off-piste), following the rates set annually by the municipal council resolution.

#### Control

SCV reserves the right to verify the Competitor's identity on the day of the Grand Prix and to ensure compliance with the Conditions. If the Competitor cannot prove their identity and adherence to the Conditions, they will be denied participation in the Grand Prix, with no right to any refund or compensation of any kind.

#### Modification or Cancellation of the Grand Prix by SCV

SCV reserves the right to modify the Grand Prix, including its date, start time, number of competitors, course layout, location of refreshment stations, or competition rules.

SCV also reserves the right to cancel the Grand Prix at any time for any reason.

In all cases, the Competitor may not claim any compensation, except for a refund of the registration fee (excluding insurance).

# Liability

SCV disclaims any responsibility for violations of the Conditions by the Competitor. It also disclaims any responsibility for damage to the Competitor's equipment, or for loss or theft of such equipment.

# Use of Images or Sounds by the Competitor or Supporter

The Competitor is prohibited from using still or moving images and sounds recorded during the Grand Prix for any purpose other than personal use, without SCV's prior express permission.

# Image Rights

By participating in the Grand Prix, the Participant agrees to participate free of charge in the creation of photographs or films (hereinafter "Images") on the day of the Grand Prix and waives any right to compensation in connection with their participation in the Images.

The Participant authorizes SCV and its agents to record their image as it appears in the Images. They also authorize SCV and its agents to use their image, voice, and statements as captured in the Images, as well as their name and first name, exclusively to promote the Grand Prix, SCV, its products, services, or brands (hereinafter "Messages"), under the terms defined in this article. The Competitor waives any right to claim compensation for the use of these rights.

This authorization includes reproduction, representation, adaptation (for artistic, technical, or commercial needs), broadcasting, and usage of the above elements on any digital or print communication media, without limitation in terms of the number of views, copies, or formats, worldwide. This authorization is granted for five years from the Grand Prix date. It allows SCV and its agents to:

- 1. Make modifications, additions, or deletions to the initial image as long as it does not alter the Competitor's personality.
- 2. Reproduce and exploit their statements in full, in part, or by quotation, and make any necessary language or terminology modifications, provided they do not alter the original meaning.
- 3. Associate the Competitor's image or supporter's image, by any means (inlay, integration, incorporation, association) with any element to illustrate the Messages.

The Competitor acknowledges that this authorization does not obligate SCV to use the elements listed in this article.

They acknowledge that SCV's and its agents' use of these rights does not violate their privacy or cause them any harm

They guarantee SCV against any legal or extrajudicial actions from any person claiming rights over any or all of the rights described in this article.

## **Personal Data**

# **Purpose and Basis for Processing Personal Data**

The personal data collected during the Competitor's registration and participation in the Grand Prix is processed to:

 Manage the Competitor's registration. This processing is necessary for the performance of the contract between SCV and the Competitor;  Respond to the Competitor's requests for information, comments, and complaints. This processing is based on the Competitor's consent.

#### **Data Controller**

The above-mentioned processing is carried out under the responsibility of SCV, represented by its general manager, whose contact details are provided in Article 1.

# **Recipients of Personal Data**

The collected data is intended for SCV and the service providers whose involvement is necessary to carry out the processing specified above.

## **Retention Periods for Personal Data**

The data collected is retained for the following periods:

- Data used to manage the Competitor's registration: five years from the date of collection if the order amount is less than €120, or ten years if the order amount is €120 or more. Exceptionally, the card number and expiration date are retained for fifteen months from the last debit date as evidence in case of transaction disputes. The security code is not retained after the transaction:
- Data used to respond to requests for information, comments, and complaints: retained for the time necessary to handle these requests, comments, and complaints.

# **Rights of Data Subjects**

The Competitor has the right to access their data, request its correction or deletion, transfer it, or have it transferred to a third party, limit its processing, or object to the processing. They may also withdraw consent to data processing at any time without affecting the lawfulness of the processing carried out before withdrawal. To exercise these rights, the Competitor must send a request to SCV's Data Protection Officer, using the contact information provided in Article 11.

SCV will comply with the request, subject to any legal obligations. For personal data protection, SCV reserves the right to request proof of identity from the Competitor or Supporter before responding to any such requests.

Lastly, the Competitor may file a complaint with the Commission Nationale de l'Informatique et des Libertés (CNIL) if they believe their rights are not being respected. # **Communication of Conditions and Registration Details**

The Competitor can obtain a copy of the Conditions.

Additionally, they may request details of their registration and the applicable Conditions at the date of registration for five years if the registration price was less than €120 including tax, or ten years if it was €120 or more.

To do so, the Competitor must send a request to SCV using the contact details in Article 11.

#### **Requests and Complaints**

The Competitor can address any request or complaint regarding the processing of their personal data by:

For any other requests or complaints, the Competitor has two months from the occurrence of the event giving rise to the complaint to contact SCV by:

# **Dispute Resolution**

In the event of a dispute between the Competitor and SCV regarding the validity, interpretation, or execution of the Conditions, the Competitor may access a free mediation procedure or other alternative dispute resolution methods.

They may contact the Tourism and Travel Ombudsman (MTV Médiation Tourisme Voyage, BP 80 303, 75 823 Paris Cedex 17, France – Phone: +33 (0)1 42 67 96 68 – Email: info@mtv.travel), following the procedures outlined on <a href="https://www.mtv.travel">https://www.mtv.travel</a>, within a maximum period of one year from the date of the written complaint filed with SCV.

Alternatively, they may use the European Commission's online dispute resolution platform, accessible at https://webgate.ec.europa.eu/odr/.

Failing amicable resolution, the Competitor may bring the matter before either one of the territorially competent courts as per the French Civil Procedure Code or the court of their residence at the time of the contract or the event causing the dispute.

# **Effective Date of Conditions**

The Conditions of Sale take effect on November 3rd, 2025.

# **Modification of Conditions**

SCV reserves the right to modify the Conditions at any time.

# **Translation of Conditions**

In case of a discrepancy between the Conditions in French and those in another language, the French Conditions shall prevail.

# **Applicable Law**

The Conditions are governed by French law.
